

**Call to Order**

Ray Lewis, President, called the meeting to order at 11:02 a.m.

A. President, Ray Lewis presented the agenda item to consider, discuss, and take action as necessary or appropriate regarding the upcoming dissolution of the Brazos Regional Public Utility Agency (BRPUA) under S.B. 1243, including the transfer of BRPUA's obligations, assets, permits, and licenses to AMUD, and the purchase of title insurance. Joel Heydenburk of Jackson Walker, LLP was present via telephone to discuss. Questions as to whether title insurance is needed was discussed. When we bought out Johnson County Special Utility District (JCSUD) we had a clear title. J. Heydenburk stated the risk to the District not purchasing title insurance is very minimal since we have the right to condemnation; this mitigates the need for title insurance.

The Board Recessed at 11:24 a.m.

The Board Reconvened at 11:30 a.m.

B. President, Ray Lewis presented the agenda item to consider Texas County & District Retirement System (TCDRS) options regarding the merger of AMUD and BRPUA.

After discussion, a motion was made to approve the AMUD and BRPUA Agreement for assumption of plan assets and pension liabilities.

C. President, Ray Lewis presented the agenda item to discuss and consider Texas County & District Retirement System (TCDRS) Plan Provisions for 2026. In merging AMUD and BRPUA, Staff is attempting to equalize employee benefits. TCDRS Representatives Erika Vasquez and Amy Campbell were present to discuss and answer questions regarding three proposed plan changes the AMUD current plan. Under AMUD's current plan provision, the employee deposit rate is 5% with 200% employer match. BRPUA has a 6% deposit rate with 200% employer match.

After discussion, a motion was made to adopt Proposed Plan 1, reflecting the employee deposit rate increase to 6% with 200% employer matching rate effective January 1, 2026.
